1. Diagram of location of Tank on Property. Diagram must include: Property Lines, Measurement (in feet) from edge of property, Identification of Supply Line(s) locations (if known), NORTH arrow marker, Identify nearest main street
3. Copy of ICC certification of UST Decommissioner performing the work (or overseeing the work)
5. By checking here \_\_\_\_\_, the tank decommissioning company attests that the property owner has been notified that he/she may have other obligations, including but not limited to, spill or leak reporting requirements under environmental or other laws apart from the International Fire Code for which he/she is responsible.
